In a reversal of a widely expected decision, the U.S. Supreme Court has ruled that the state of California can force landlords to pay triple the amount of a mortgage for owner-occupied homes. The decision is a major victory for California tenants who have been pushed into homelessness due to their landlords' rising rents, during a period of high unemployment and foreclosure rates. The Supreme Court said in its ruling that the state law defining the affordability gap and requiring "just cause" notice of eviction is constitutional, even though it may deprive renters of the right to due process in the eviction process. "The rent in this case is increasing much more rapidly than the rents of other properties in the area," Justice Stephen Breyer wrote for the majority. "The rent increase is so great that tenants would be unable to remain in their homes and would have to become homeless." The California law was heavily criticized as an attempt to punish homeowners and business owners for economic woes caused by the housing and foreclosure crisis. California Gov. Jerry Brown signed the law on Oct. 17, 2011. It requires landlords to provide tenants with a written notice of a rent increase as high as 10 percent. If a landlord does not provide the notices or leaves the rent increase unchanged, tenants may be entitled to three times the amount of the increase. Landlords may also be liable for other damages under the law, such as the cost of moving out. Critics of the legislation, including the California Apartment Association, said the law unfairly targeted the state's residents while ignoring the role of wealthy speculators in the housing market. They argued that the law could have a serious financial impact on many Californians, by forcing landlords to raise rents to cover their costs. After the law was signed, the California Apartment Association sued to stop it. A lower court ruled in favor of the association, but the Supreme Court reversed the decision. A second law passed in April requires landlords to allow tenants to stay rent-free in their homes if they live in the home for at least 30 years. MicroRNA-182 Induces Glioma Cell Migration via Targeting of Neural Cell Adhesion Molecule 1. Glioma is one of the most common and lethal forms of brain tumors. Emerging evidence has demonstrated the important role of microRNAs (miRNAs) in tumor progression, including glioma. However, the correlation between miRNA expression and glioma cell migration is poorly understood. In this study, we identified that miR-182 was significantly upregulated in human glioma tissues and cells. Overexpression of miR-182 in human glioma cells increased cell viability, colony formation ability, and migration. Conversely, knockdown of miR-182 resulted in the opposite effects on glioma cells.

Neural cell adhesion molecule 1 (NCAM1) was identified as a target of miR-182. Mechanistically, overexpression of miR-182 increased NCAM1 protein level, while knockdown of miR-182 suppressed NCAM1 protein level. Furthermore, miR-182/NCAM1 axis promoted cell viability, colony formation, and migration in human glioma cells. These results provide a novel mechanism for the role of miR-182 in glioma cell proliferation and migration, which might provide therapeutic strategies for glioma.
